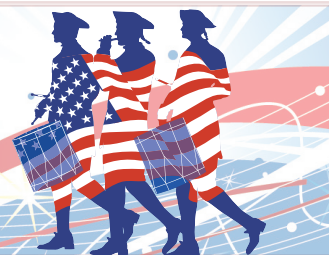
I sincerely welcome and encourage your feedback on how we can improve and operate more effectively in order to make Texas Bridge Credit Union your financial institution of choice.

I understand that the net effect of the deferral will be to lengthen the term of my loan. **Any loan with Skip-A-Payment granted in June, July or August will not qualify for December Skip-A-Payment.**
