

TXBCU in the Community

Texas Bridge Credit Union recently donated 5,000 N95 masks to the Corpus Christi Police Department and Corpus Christi Fire Department.

Each department received 2,500 masks to be used by local first responders.

The donation took place at TXBCU's Gollihar office and was attended by TXBCU's Board Vice-Chairman Roland Barrera and President David Brooks. CCPD Chief Mike Markle and CCFD Chief Robert Rocha were also in attendance.
