**Avoid Holiday Shopping Scams**

*Protect yourself from being a victim of fraud this holiday season by looking out for these top holiday shopping scams:*

**Online Shopping Scams**

Watch out for fictitious retail sites spoofing real sites for fabricated retail brands. Double-check and look out for spelling errors in the domain name. Also, watch out for deals that are too good to be true. If a luxury item is selling at an unreasonably low price, it might be a fraudulent retailer phishing for payment information

**Charity Rip-Offs**

Unfortunately, fraudsters use the holidays to play off our charitable spirit. Through email, text and phone calls, fraudsters will pressure victims into check, cash or money order contributions. If you are thinking of giving this year, give to an organization you know and trust and contact them directly.

**Holiday E-Card Scams**

Watch for phishing scams – an email-based fraud tactic. Do not open emails if you don’t recognize the sender. Further, don’t click on any of the links if the email looks suspicious – this might install malicious software on your computer, giving fraudsters access to your personal information.

**Don’t Overshare**

Be safe online and avoid oversharing information. This includes posting pictures that accidentally have your credit card or driver’s license in the background or giving an app or website an inordinate amount of personal information. Always bring a healthy amount of skepticism when transacting online.
