Texas Bridge Credit Union is now posting direct deposits up to 2 business days early and with no fee! Enjoy getting your paycheck or federal benefits deposited into your account faster than before.

If you already receive ACH direct deposits then there is nothing more you need to do to enjoy this feature.

If you do not currently have ACH direct deposit established, simply provide TXBCU's routing number 314978404 and your account number to your employer or payer.

*TXBCU cannot guarantee all credits will be posted up to 2 business days early. Posting of funds are dependent on payer's submission of ACH deposits to TXBCU. It is recommended that members verify funds have been posted to their account prior to conducting transactions.

Any loan with a Skip-A-Payment granted in June, July or August will not qualify for December Skip-A-Payment.
