Thank you for your interest in the Texas Bridge Credit Union scholarship program in partnership with Education is our Freedom. Please read this page carefully as this application is subject to change. We will ask you to sign your application stating that you have read and understand this information. The Texas Bridge Credit Union Board of Directors will determine the number of and dollar amount of scholarships that are to be awarded.

To be considered for the scholarship, a student must provide the following information. If any information is missing or not provided, it may result in disqualification of the applicant for this scholarship.

- **The applicant and/or their parent(s) or legal guardian(s) must be a member in good standing at Texas Bridge Credit Union when submitting the application. Employees and Board Directors of Texas Bridge Credit Union are not eligible for this scholarship program.**
- TXBCU scholarships will be awarded to a recipient a maximum once per calendar year in the high school senior and post-secondary categories.
- Applicants must sign an authorization and/or consent waiver agreement for the use of their name and photo in future advertisements of scholarship recipients by Texas Bridge Credit Union.
- Be currently enrolled or planning to enroll in an accredited community college, 4-year college or university, or a program leading toward a GED or vocational or technical degree.
- Be enrolled in a minimum of six (6) college credit hours per semester.
- Submit an essay.
- Completed applications must arrive at the Texas Bridge Credit Union Holly office by the close of business, **Friday, March 13, 2026 at 5:00PM** of the current year (for the Fall Semester 2026) for full consideration of the selection committee. **Applications submitted after the stated deadlines will not be accepted.**
